ARTICLES OF INCORPORATION

of

THE GLIDE COMMUNITY CLUB

We, ELBERT N. CELLERS, RAYMOND O. BALLOU and M. H. McCORD, whose names are hereunto subscribed, desiring to form a corporation under and by virtue of Sections 61.010 to 61.130 Oregon Revised Statutes, as amended, providing for the creation of non profit corporations, do hereby associate ourselves together and make and execute, in triplicate, the following Articles of Incorporation, to-wit:

ARTICLE I

The name assumed by this corporation and by which it shall be known

THE GLIDE COMMUNITY CLUB

and its duration shall be perpetual.

ARTICLE II

The corporation shall not engage in any form of trade or commerce or carry on any activity which will result in a remunerative profit to the corporation, or to its members. Subject to the foregoing limitations, the object, business or pursuit of this corporation shall be as follows:

- To provide the community of Glide, Oregon, and the residents thereof, with a non political, non profit and non denominational social organization.
- 2. To provide the community of Glide, Oregon, and the residents thereof, with an organization for the promotion of community betterment.
- July 9, 1927, recorded in the office of the County Clerk of Douglas County, Oregon, on January 21, 1928, as Recorder's No. 71334, a community hall for the uses and benefit of the inhabitants of Glide, Oregon, and vicinity, for all community purposes, including the advancement of agriculture and education,

in accordance with the provisions of said deed.

- 4. To lease, purchase, hold and enjoy, in fee simple or otherwise, any real or personal property necessary for the uses and purposes of this corporation, and to sell, lease, convey and encumber or otherwise dispose of real or personal property and to apply the proceeds thereof, if any, to the uses and purposes of this corporation.
- 5. To do any and all other lawful things which may be or may become necessary or convenient or expedient for the purposes above stated.

ARTICLE III

The estimated value of property and money possessed by this corporation at the time of making these Articles of Incorporation is Five Hundred and No/100 Dollars (\$500.00). The sources of revenue or income of said corporation will be from membership dues, donations and voluntary contributions.

ARTICLE IV

The governing body which is to exercise the powers of the corporation shall be a Board of Directors consisting of four (4) officers, namely,
President, Vice President, Secretary and Treasurer, and an Executive Committee
of not less than three (3) members nor more than five (5) members; said
officers and said executive committee members shall be duly elected from
the membership by the majority vote of the members at an annual meeting to
be held on the third Wednesday of January of each year hereafter.
