<u>Rentals</u> - Dom Mosca made the motion to exclude animals from inside the building. Don Kidd second. Motion passed.

Bingo –Dom reported that the attendance for bingo has picked up.

<u>Reader Board</u> – Dom talked with Marti from the Job Corps and they are going to redesign the board.

<u>First Citizen</u> – Nancy Tague reported that the committee would be meeting soon to plan the event for next year. The plan is to have it earlier in the year possibly March. Anyone interested to be on the committee is to get in touch with her.

<u>Event</u> – Dom reported that they have had two meetings and are planning the Halloween party on October 28<sup>th</sup>. Kruse Farms is donating about 50 pumpkins. Also in the plans are a Memorial Day or Fourth of July Parade. We will need a sponsor and they have talked with ODOT.

<u>Floor</u> – Doing the floor is on hold. We have \$800 earmarked for the floor and also have \$500 from the Arts & Crafts Fair that we could put towards the poly for the floor.
