Treasure report by Lois Spence. Total income for May: \$2,928.00 less expenses of \$1,752.66. Total account balance for May: \$24,169.71.

OLD/UNFINISHED BUSINESS

1. Patricia Gilbert was to address the Glide Community Club re: storage for Wild Flower Show. Due to previous commitment she was unable to attend. She did however send an e-mail concerning the weight on the boxes in the storage shed. Nancy will contact Patricia Gilbert to see what their intentions are to resolve this problem. We need a time limit for it to be done. They still have an option to build a storage shed out back.

The scholarship committee was able to donate \$1000.00 this year. \$50.00 from the bingo fund and \$950.00 from the food sale at the Wild Flower Show. The recipient this year was Casey Alan Walker who sent a thank you letter for the donation and stating that he will be attending Oregon State University to earn a degree in civil engineering.
2. Progress on the roof was reported on by Bill Scheufele. The roof will be finished on Wednesday June 27 and we might have enough roofing for the storage shed roof. The paint has been purchased from Sherwin Williams for \$1,146.50. Now we need room to store the paint.
3. Dom Mosca was unable to attend the meeting so there was no report on the reader board.
4. A very much needed copy machine was located here in Glide from Ed Young who answered our bulletin board ad and contacted George Roman. He will still try to find us a tape recorder.
5. Membership drive by Charlotte Reed will be addressed at a later date.

NEW BUSINESS

1. Glide Community Club received a check in the amount of \$333.21 from the Wildflower Show, This amount is comprised of 10% of their door donations and two days of lost Senior Center rental per their long standing agreement.
2. Correspondence from the Ford Foundation stating that if we want to be on their list for a grant for next year we have to submit a request with all necessary information. This is on hold for now.
3. We will address the landscaping around the building when all the work on the roof, gutters and paint is finished.
