Treasure report in absence of Lois Spence read by Joyce Betry.

Total income for August 2007, \$606.75, total expenses \$1,989.20 leaving a negative total of \$1,382.45. Total income to date \$13,755.40. Total expenses \$24,148.10 leaving a negative total to date of \$10,392.70. Bank account balances as of August 31, 2007, \$20,789.44.

Both reports approved as read.

**OLD/UNFINISHED BUSINESS**

1. Outside storage by the Annex building has been taken care of by Bill Scheufele and Don Kidd. They will clean up all metal pieces around Glide Community Building after the gutters are on. Doors have been put on the furnace room. If there is a problem with ventilation, screens will be installed.
2. The gutters go on the building on the 26<sup>th</sup> of September.
3. We still have not gotten the letters and numbers for the reader board. Dom will make a trip to the Wolf Creek Job Corp to contact Marty and get this resolved.
4. We have to again contact Marty at Job Crop to see about painting the inside of the building. We may have to paint inside ourselves so we need to get scaffolding; It was also suggested that in our next contract with the seniors we need one week set aside for maintenance each year.
5. Our calendar has been updated with all rental dates.
6. We still need material for the floors. Susan wants to look at floors in Yoncalla. We also have to address the slope into the kitchen.

**NEW BUSINESS**

1. Graffetti weekend. We should have a proposal from Bill Roberts in writing to the Board Members on his outline of ideas and how we can participate. Insurance rider for the event was discussed. Other questions or concerns will be addressed as they come up.
2. The estate sale by Susan and Donnabell brought in \$500.00.
3. Sandwich boards were made for bingo/garage sale for a cost of \$200.00. They cannot be put out on the highway but we have enough room off highway on each side of the road to put them out when we need them. Motion was made and seconded to approve sign boards. All in favor except one vote.
