#### OLD/UNFINISHED BUSINESS

1. Landscaping. Until the dry rot is addressed, the landscaping will not be done. We will notify Dan at Shamrock Nursery when we are ready.
2. Roof and Misc projects completed. New septic cover in place. Metal donated by Roseburg Lumber Co. New bumper block for in front of cover donated by Randy Ferguson. Ditch digging done by John Kroll. Gravel provided by Bjorn Vian. Culvert pipe donated by Gordon Spezza Trucking. The tin in back has been sold for total of \$333.00. There is some tin left over. The shingles have been burned and things are looking good. All of these people have been sent a thank you letter for their donations.  
New problem with flooding under building. How to fix the area was discussed by Don Kidd. A sump pump was discussed, also continuance curbing in front of the building to drain the water to the side so it can be channeled into the ditch out back. After this is fixed the area that is graveled will be paved and stripped.
3. The flooring was discussed and samples were brought in by Bill Scheufele and Susan Flury. Prices were discussed on several samples and several bids are on file with Susan. We have the check from the Ford Foundation in hand and Susan Flury read all correspondence from the Ford Foundation. We probably will not start flooring until after the first of the year.
4. Mike Keiser. We did receive an e-mail from him slating he has resigned from the board and Lois Spence will bring a copy of that e-mail for our file.
5. The Halloween Party will be on October 29th from 1:00 to 3:00pm. Job corp will come again to help carve pumpkins for us.
6. Jeannie's light will be installed by Dennis Moore. We also need to replace one bulb in the overhead light in the community club.
7. Susan will give Tuck a call so we can get a verbal agreement so we can remove the computers upstairs. Also a registered letter should be sent to give him 10 days to respond so we can get the computers removed if no response from the phone call.
8. The roader board is an on going problem. Jim Betry picked up the letters that were available but was told that they were incorrect. Dom had discussed a different material that was supposed to be used. He talked with Marti at Job Corp to see if we can get this problem worked out.
